WKKO-FM/WXKR-FM/WQQO-FM/WRQN-FM/WMIM-FM/WQQO-HD2/WXKR-HD2 "UGLIEST DRIVEWAY" CONTEST OFFICIAL RULES

The Stations will conduct the WKKO-FM/WXKR-FM/WQQO-FM/WRQN-FM/WMIM-FM/WQQO-HD2/WXKR-HD2 "Ugliest Driveway" Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:
